Non-Refundable Puppy Application Fee Agreement

This agreement (“**Agreement**”), dated as of _____, 20__ (the “**Effective Date**”), is between **Strahl Von Valor Shepherds** (“**Breeder**”), and _____ (“**Buyer**”). Buyer agrees to place a **Three Hundred Dollars (\$300.00)** Application Fee (“**Application Fee**”) on a German Shepherd puppy from Breeder.

The Application Fee will be due in two parts: **\$100.00** at time of Application Approval and **\$200.00** at birth of puppies.

1. **Non-Refundable Puppy Application Fee:** Buyer acknowledges that the Application Fee is non-refundable in all circumstances, including but not limited to if Buyer decides s/he does not want or is no longer able to take the puppy. Upon receipt of the Application Fee, Breeder agrees to hold the puppy for Buyer until it has been weaned and is ready for pick up. The Application Fee shall be made in US Dollars and paid to Breeder via payments through Good Dog.
2. **Buyer Acknowledgements.** Buyer further acknowledges and agrees that (a) Breeder cannot control litter sizes and that the wait time for puppies can be longer than expected; (b) the Deposit gives Buyer a “pick” place, but does not guarantee a puppy or that Buyer’s preferences will be available when it is Buyer’s turn to pick; (c) pick places are given on a first-come first served basis and Buyer’s place in line is not negotiable; (d) Breeder cannot and does not guarantee any specific qualities of the puppy when it becomes an adult; (e) Breeder will recommend picks based on temperaments and buyers needs before coat/color preferences to ensure the right fit for both you and the puppy.
3. **Buyer’s Right to Transfer/Refund.** Notwithstanding the foregoing, if a puppy that meets Buyer’s identified preferences is not available [when it becomes Buyer’s turn to pick a puppy from the selected litter], Buyer may elect (a) to have the Deposit transferred to another litter on one occasion or (b) have the Application Fee refunded.
4. **Refund at Breeder’s Discretion.** If Buyer pays the Application Fee, then later decides s/he does not want the puppy for any reason, Breeder is not required to refund the Application Fee. If Buyer pays the first \$100 then is unresponsive for 7 days after the birth of the puppies Buyer will forfeit their deposit.
5. **Final Purchase Price.** Breeder and Buyer agree that (a) the Application Fee shall be applied to the final purchase price of the puppy and (b) the remaining balance will become due before the puppy is shipped and/or ownership is transferred from Breeder to Buyer. The total purchase price for the puppy is **One Thousand Five Hundred Dollars (\$1,500.00)**. The foregoing purchase price does not include any delivery or shipping charges.
6. **Governing Law.** This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of Arkansas without regard to the conflicts of laws provisions thereof.
